### **Support the Appointment and Confirmation of Illinois AFL-CIO Members to the Illinois Boards and Commissions**

**WHEREAS**, currently there are over 300 State of Illinois Boards and Commissions that have a tremendous influence over the lives of working people in Illinois and Governor JB Pritzker has made appointing members of the Illinois labor community a priority; and

**WHEREAS**, these boards and commissions oversee the education of our children, workers organizing rights, consumer protections, injured worker rights and unemployment benefits. They also make decisions regarding investment in vital infrastructure such as water and sewer systems, mass transit and highway construction; and

**WHEREAS**, Governor Pritzker has appointed and the Senate has confirmed Michael Kleinik (LIUNA) as the Director of Labor and James Connelly (LIUNA), James Sweeney (IUOE) and Gary Perinar (UBC) to the Illinois State Toll Highway Authority; and

**WHEREAS**, with the support of Governor Pritzker, James Underwood (IBEW) was elected Executive Director by the Capital Development Board; and
